The Sheldon School district has met with teachers, administrators and parents to discuss services. The district has chosen iREADY for the assessment tool to progress monitor and benchmark achievement of identified students to better target needed skills and group students for interventions in areas of reading and math. Interventions support success for Title 1 students will include but not limited to tier intervention programs such as RTI, Wonders Reading program, READY math program, DI practices, Assessment Capable Learners practices, Accelerated Reader, Secret Stories and the 6 Trait Writing Program. Parents are provided with copies of the MAP results during Parent Teacher Conferences in the fall. Parents are given copies of the diagnostic test results after each test cycle.
